In the meantime, in order to comply with my firm's identification procedure, please provide me with two forms of identification as set out below (one from section (A) and one from section (B)).

Please note only original documents (or photocopies certified by a solicitor as true copies of the original documents) are acceptable:

(A) as evidence of your name one of the following:

- a current full signed passport;
- a current full UK driving licence;
- a state pension or benefits book;

- an Inland Revenue tax notification; and

(B) as evidence of your address one of the following:

- a bank/building society statement or passbook;
- a utility bill (not for a mobile phone);
- a local authority tax bill

In the event that you have changed your name since your date of birth, eg due to marriage, or your name is different from that stated in the { IF { MERGFIELD FW_PRODCDETS_1_FWTESTATE } = "Testate" "Will" "family tree" }, then please provide the necessary Certificates/Change of Name Deeds evidencing this change.

Please also confirm how you would like your funds paid to you. You have three options:

1. your funds can be sent to you in the form of a cheque at the above address;
2. your funds can be telegraphically transmitted to your bank account via the CHAPS system, which credits your account instantly and for which there is an administrative charge of £* ; or
3. your funds can be telegraphically transmitted to your bank account via the BACS system, which takes 4 days to clear into your account.

If you request your funds to be electronically transferred to you, I will require the account holder's name, bank name and branch address together with the sort code and account number. If the funds are being transferred to an account based abroad, I will also require the IBAN number and swift code.
