You will need an active subscription with DocuSign to be able to benefit from Osprey's DocuSign integration.

Clients will need access to the client web portal to be able to sign in and review any pending signature requests.

Logging in

To sign into DocSign, left-click Case Management. This will load the Documents tab. Select a word document you wish to request a signature on, and select Request Signature (DocuSign)
